## POWDER HORN POOL & FITNESS CENTER

The Powder Horn Fitness and Swim Complex is a facility for club members and their guests. Relax to the sounds of a trickling waterfall built into the pool's adjacent rock wall, one of the unique features of The Powder Horn's natural landscape. The pool area is complete with an outdoor lap pool, separate children's pool, therapy spa and poolside grill. Complimentary towels are provided for members. The private fitness center has a variety of cardio equipment, including elliptical machines, treadmills and stationary bicycles. ## POWDER HORN TENNIS

The Powder Horn Golf Club has two premium tennis courts adjacent to our pool and fitness center. Club Members are responsible for paying all initiation fees, membership dues, golf cart fees, all other applicable use fees, Club Account balances, and any other charges the Club requires the Premium Golf Member to pay.

A Membership may be held by only one person. Notwithstanding any joint ownership of property interests, the Membership shall be entitled to only one person. Memberships are personal to the holder thereof, and may not be assigned or transferred, except with expressed written consent of the Club.

At the request of any Premium Golf Member, and subject to such Member's continuing consent, the spouse of such Member and the unmarried children and stepchildren of the immediate family of such Member and spouse under the age of twenty-three (23), living in the Member's household, shall be permitted to use all facilities of the Club upon such terms and conditions as the Club Owner shall prescribe in accordance with the Club Policies and Rules.

Club Members are responsible for paying all initiation fees, membership dues, golf cart fees, all other applicable use fees, Club Account balances, and any other charges the Club requires the Individual Member to pay.

A Membership is held by only one person. Notwithstanding any joint ownership of property interests, the Membership shall be entitled to only one person. Memberships are personal to the holders thereof, and may not be assigned or transferred, except with expressed written consent of the club.

At the request of any Individual Golf Member, and subject to such Member's continuing consent, the spouse of such Member and the unmarried children and stepchildren of the immediate family of such Member and spouse under the age of twenty-three (23) living in the Member's household, shall be permitted to use all non-golf related facilities of the Club upon such terms and conditions as the Club Owner shall prescribe in accordance with the Club Policies and Rules. Use of the golf course or golf facilities by the Member's spouse or children, under the age of 23 yrs. is subject to restrictions and the payment of guest fees.

Club Members are responsible for paying all initiation fees, membership dues, all other applicable use fees, Club Account balances, and any other charges the Club requires the Social Recreation Member to pay.

A Membership may be held by only one person. Notwithstanding any joint ownership of property interests, the Membership shall be entitled to only one person. Memberships are personal to the holders thereof, and may not be assigned or transferred, except with expressed written consent of the club.

At the request of any Social Recreation Member, and subject to such Member's continuing consent, the spouse of such Member and the unmarried children and stepchildren of the immediate family of such Member and spouse under the age of twenty-three (23), living in the Member's household, shall be permitted to use all non-golf facilities of the Club upon such terms and conditions as the Club Owner shall prescribe in accordance with the Club Policies and Rules.

### **FEES AND DUES:**

One-time payment of \$1250 is required at time of application. Dues will be \$195, paid monthly. Initiation fees and dues are subject to change at the sole discretion of the Club Owner and are NON-REFUNDABLE.

A Membership may be held by only one person. Notwithstanding any joint ownership of property interests, the Membership shall be entitled to only one person. Memberships are personal to the holder's thereof, and may not be assigned or transferred, except with expressed written consent of the club.

At the request of any Social Clubhouse Member, and subject to such Member's continuing consent, the spouse of such Member and the unmarried children and stepchildren of the immediate family of such Member and spouse under the age of twenty-three (23), living in the Member's household, are permitted to use all clubhouse facilities of the Club upon such terms and conditions as the Club Owner shall prescribe in accordance with the Club Policies and Rules.

### **FEES AND DUES:**

One-time payment of \$200 is required at time of application. Dues will be \$105, paid monthly. Initiation fees and dues are subject to change at the sole discretion of the Club Owner and are NON-REFUNDABLE.

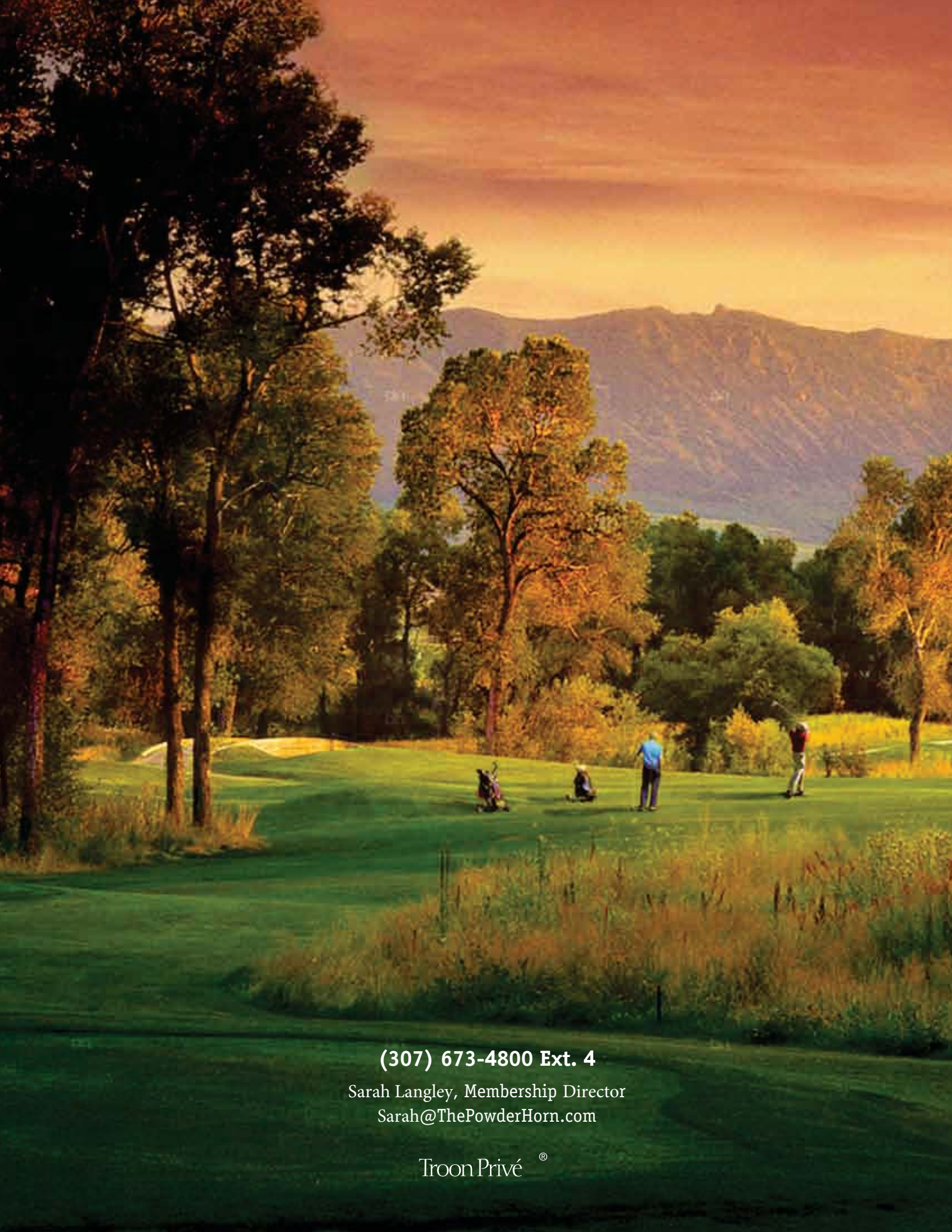
